



2022 CONSOLIDATION DEPOT SERVICES

Stahmann Webster provides two Consolidation Depots throughout the macadamia growing region of Northern NSW to assist growers in delivering NIH and NIS to Stahmann Webster. These depots are Summerland Farm (Alstonville) and Southridge Farm (Clunes).

Delivering Your Nut

It is ESSENTIAL that all deliveries are booked into depots PRIOR to delivery. Booking times and delivery details must be adhered to. Unfortunately deliveries made without bookings may remain unprocessed until a vacant booking slot becomes available. In this instance, any loss of nut quality is at your risk.

Quality and Food Safety

Consignments delivered to our Consolidation Depots must conform with the Standard Load requirements detailed on the following page.

At the discretion of each Consolidation Depot if the load (bins, skip, truck or ute) does not meet the Standard Load quality requirements, or is deemed to have excess stick, branch, dirt, rock, leaf or other contaminants that will breach HACCP or Foods Standards, or significantly reduce the dehusk throughput rates, the Depot may reject the load and refuse to dehusk until the load is corrected or removed. The grower and Stahmann Webster will be informed within one business day of the load arriving at the Depot.

The cost of removing or correcting a rejected load will be at the grower's expense.





STANDARD LOAD

In addition to the quality and food safety requirements specified on the previous page, the following constitutes a Standard Load:

Foreign Materials	Materials that do not grow on the macadamia tree or are not naturally found on the orchard floor: <ul style="list-style-type: none"> • Significant food safety hazards (e.g. rat baits) 	Significant food safety hazards - nil allowed
	<ul style="list-style-type: none"> • Other foreign materials (e.g. irrigation fittings, finger wheels) 	No more than 1 piece/tonne
Trash	Leaf	A maximum of 20% by area
	Stick less than 100mm in length	Less than 45 pieces/tonne
	Stick greater than 100mm long	No more than 5 pieces/tonne
	Rock	Less than 20 pieces/tonne
	Dirt/soil	A maximum of 5% by area
Nut in Husk	Nut in shell that is encased in husk	Up to 100%
Booked Quantity	This is the quantity of material that is booked for de-husking and/or other services. This may be in the form of weight (kg or tonne), number of field bins or skip size.	110%
